The petitioner is James Fly, a state prisoner, who commenced this proceeding to secure a writ of habeas corpus. He was indicted in Los Angeles County on a charge of murder and prior thereto had been committed to the state prison at San Quentin. On June 24, 1935, while he was still confined in said San Quentin prison, he was indicted on the present charge, the record indicating that he had at the time of his arraignment on the latter indictment been on parole. He alleges that he had never before been placed in the custody of the state department of corrections but had been kept in the county jail. At the hearing of the habeas corpus proceeding he introduced a certificate of the director of the state prison at San Quentin showing that he was a state prisoner, was confined there, had never been released on parole and was in the custody of said director. In the answer it was alleged that upon the arraignment of the prisoner he had been charged with the crime of murder and a further arraignment had been had at which time the defendant had pleaded guilty and had been found guilty of murder in the first degree with three prior convictions. The sheriff of Los Angeles County testified that the defendant was confined in the county jail awaiting sentence and had never been released. To the petition and the return, defendant made no objection and offered no evidence. He asks that the writ be issued and that the commitment be declared void. [1] It is insisted on behalf of the petitioner that he is entitled to his release on the ground that he had never been lawfully or legally sentenced by the trial court. We can see no force in this contention. The record discloses that he was arraigned on the charge of murder, that he entered a plea of guilty and was found guilty of murder in the first degree with three prior convictions.
